 - i. Answer: Yes, Asphalt for interim pavement will be paid for under Superpave Asphaltic Concrete Wearing Course (2.5" Thick) bid item.

 - b. Will the geotextile and geogrid installed as part of the interim pavement be paid for under the bid items "Geotextile Fabric For Stabilization" and "Geogrid"?
 - i. Answer: Yes, the geogrid and geotextile fabric for interim pavement will be paid for under the Geotextile Fabric For Stabilization and Geogrid bid item.

 - c. Will the 12" of Base Course required as part of the interim pavement be paid for under the bid item "Base Course"?
 - i. Answer: Yes, the base course for interim pavement will be paid for under the Base Course bid item.
