The day will be 24 hours from check in time. Line 10	<p><b>Returnable Ice:</b></p> <p>Price per pound that will be issued as a <b>credit</b> back to the agency for purchased ice that will be returned in full, unopened reefer trailer(s) on which the seal <b>has not</b> been broken.</p> <p><b>Once the Contractor has been notified that the ice is no longer needed, all reefer trailer rental charges are to stop immediately.</b></p>	LB	1		
Line 11	<p><b>Unused Ice:</b></p> <p>Price per pound charged to pick up unused ice in reefer trailer(s) on which the seal <b>has</b> been broken.</p> <p><b>Once the Contractor has been notified that the ice is no longer needed, all reefer trailer rental charges are to stop immediately.</b></p>	LB	1
