Yes. This solicitation is to establish Statewide Emergency Contingency Contract(s), which will only be activated for use if an emergency is declared by the Governor of the State of Louisiana. It is separate and apart from any regular statewide equipment rental contracts which are active for use year-round, and is intended to supplement those contracts. Emergency contracts also typically include disaster-related special requirements.
