Labor, Materials & Equipment necessary to furnish & install Aluminum Bleachers at various playground locations for the Jefferson Parish Recreation Department

Questions & Answers

1) **QUESTION:** Section 8 on page 37 states "Inflammable material must be removed from the job site daily, because storage will not be permitted on the premises." but there is no clarification on inflammable materials. Will there be onsite storage for the aluminum planks and hardware at these locations?

ANSWER: We will find an area in the park for the materials.

2) **QUESTION:** Section 11 on page 37 states "Upon receiving a Notice to Proceed, the successful bidder agrees that all work to be completed within 90 DAYS from the date of notice to proceed." The 55'6" bleacher for Kings Grant Playground has a 12-14-week lead time per the manufacturer. Will this be acceptable?

ANSWER: Yes, this will be acceptable.

3) **QUESTION:** Some of the bleachers in Line Item #1 and Line Item #2 will be sitting directly on the grass/dirt. The manufacturer typically provides 2x6 #1 Treated Southern Yellow Pine runners under each frame to disperse the load so the bleachers don't sink into the ground. Will you be requiring these?

ANSWER: Yes, we will require the runners.

4) **QUESTION:** to meet wind load requirements, all bleachers in Line Items #1, #2, and #3 should be tied down using auger anchors if on grass/dirt OR anchored down to the concrete base with concrete wedge anchors. Will those also be required?

ANSWER: No, we do not want the bleachers anchored down.
