AD2-1 MODIFICATION TO SPECIFICATIONS AND QUESTIONS/CLARIFICATIONS

1. The estimated cost range noted on the “Public Works Bid Instructions” under Section B is for informational purposes only and may be subject to change. The bid prices received from bidders will be evaluated based on the actual estimate value, which will be read aloud at the time of bid opening, for award determination.
2. Due to the St. Patrick’s Day Parade scheduled to run along Metairie Road on March 17, 2025 and other St. Patrick’s Day Parade events, contractor will not be allowed to work from 7 AM, Friday, March 15, 2025 through 7 AM, Monday, March 18, 2025. The contractor shall secure the site for safe pedestrian travel by the Friday before the parade at 7AM. If necessary, these restrictions and requirements will also be in place during the 2026 St. Patrick’s Day Parade.
3. Q. The Contract shows 545 Calendar Days for completion time, with the Liquidated Damages of \$2,000.00 per Calendar Day. The second paragraph has additional hourly fees for Architectural/Engineering, Resident Project Representative, Construction Management, and Parish's Overhead & Personnel Expenses. Is the contractor penalized these additional fees only if the contractor exceeds the 545 calendar days, or is it only penalized if the contractor exceeds the Parish's budget for inspection cost of \$271,173.00?
  - A. Additional Liquidated Damages listed in Paragraph 2 are only assessed if the contractor fails to complete the project within the contract time in addition to the per day Liquidated Damage rate of \$2,000.00.
4. Q. Will the contractor be allowed to work on a 7 day a week/10 hours per day work schedule? If not, what is the total amount of work hours a contractor is allowed to work in a week?
  - A. Yes, 7 days per week with 10 hour work days will be allowed, except on holidays unless advanced in request and approved by Jefferson Parish.
5. Q. Will night work be allowed for blast cleaning & painting? And will this be acceptable per the Jefferson Parish noise ordinance?
  - A. Contractor must adhere to Noise Ordinance when working within 300 ft of residential or noise sensitive areas.
6. Q. Is TSP Air Monitoring required daily for blast cleaning operations, or only during the first week of work?
  - A. Contractor must adhere to OSHA requirements as described in 29 CFR 1926.62.

7. Q. Is the contractor required to contain the wash water for Concrete Cleaning?  
A. The contractor is required to contain and properly dispose of off-site, in accordance with all federal, state, and local laws, rules, regulations, and ordinances, wash water that contains mold, mildew, and/or other foreign material removed during cleaning.
