2	I just wanted to see what type of window cleaning you are talking about. Are y'all wanting a maintenance clean, or are y'all wanting a restoration bid, to remove hard water stains etc.	All of that is outlined in the bid specifications. This is window cleaning on an as needed basis.
	I know the pre-bid meeting Isn't mandatory, but are vendors allowed to walk the outside of the buildings for viewing on any other day(s)?	That is the only time that will be scheduled to view the interior of some of the buildings and we encourage anyone interested to attend at that time. Vendors are more than welcome to walk the grounds of the campus but will not be allowed to discuss anything related to the bid, and may not be allowed access to all areas.
	What type of license is needed from vendors?	The vendor must be a licensed business in the State of Louisiana.

If a vendor does not have any company owned vehicles, they will still be asked to provide proof of automobile insurance for any vehicle driven onto campus grounds. A waiver of subrogation only applies to Workman's Compensation Insurance and is in favor of the College.
	In times of bad weather, will more time be allowed to complete a task and/or schedule?	Generally, exterior work is not scheduled in bad weather. This contract is based upon the cost per square foot and not per hour. However, vendor is expected to perform tasks in a timely manner.
	I'm NOT understanding the pricing matrix, Is there another/better way to do it?	Please see page 22. The majority of the work takes place where the wall heights are between $11' - 20'$ high. Therefore the percentage of that category is weighted higher. If you bid \$10 per square foot for work in that category, the calculations would be 33% x 10 equals the weighted value of 3.3. The lowest overall total is the lowest bidder.
	Is it possible to get the square footages and number of floors for each building? City Park Campus, West Bank Campus, Sidney Collier Campus and River City Campus?	See attached for square footages. Please note this is for window cleaning <u>only</u> . Most buildings are single story, with a few that are that are 2 and some 3.
