Your reference is directed to RFx Number 3000023023 for the Invitation to Bid (ITB) for the State of Louisiana – Auditorium Curtains - DPS, which is currently scheduled to open at 10:00 AM CT on 06/11/24.

The following changes are to be made to the referenced solicitation:

Questions from the Vendor and State's Responses:

Vendor Question 1. There are 8 curtains total covering the windows in the Lobby. Are there a couple damaged that they are wanting to change while leaving the others up?

State's Response: We have a total of eight (8) curtains in the lobby that are to be replaced. See revised Scope of Work

Vendor Question 2. Stage Ceiling Curtains – The quantity is listed 20 and that is an accurate description of what they have up there now. They evidently bought some small 4'W x 4'H pieces of curtain and tied them up on the pipes and pinned them together to make it look like one long piece of curtain. We can accomplish this with just 3 panels of curtain.

The Valance is the front curtain hanging in front of the big curtains that opens and closes. It is made out of the same material as the lobby curtains.

The 2 Borders are each one long panel with no seams that run the entire width of the stage and hide the tracks on the sides and rear of the stage, thus the quantity goes from 20 to 3.

State's Response: Correct, the 4X4 curtains were only in place as a temporary fix. You are welcome to replace them with two curtains that span the length of the ceiling. Per attachment B Scope of Work new curtains may be different sizes/quantities but they must cover the entire area that the existing curtains cover.

Vendor Question 3. Rear and Side Stage Curtains – Quantity is listed as 11 and that is an accurate description of what is there now but we can accomplish the same thing with fewer panels.

The Rear Curtains are now 5 separate panels all pinned together to try and stop the light from coming through from behind. We would do this with two large panels that meet in the middle of the stage.

The Side Curtains are 6 Panels and that is what we will provide as well thus the total number of panels is 8: 2 rear and 6 sides
