Current copy of License issued by Structural Pest Control Commission, State of Louisiana, to engage in business of eradication of household insects and rodent control and bird control and small animal control.

Please strike the language highlighted above so that the statement reads:

List of at least five (5) commercial accounts serviced in the last twelve (12) months, including contact person and telephone number.
